

## **PJ's-SentryWorld Only at PJ's SWEEPSTAKES**

**\*\*The Sponsor revised the Official Rules on August 30, 2019. The only change is that the Sponsor is adding a new Sweepstakes (September 1-September 30, 2019). The Official Rules otherwise remain unchanged.**

### **OFFICIAL RULES**

- **NO PURCHASE NECESSARY TO ENTER OR WIN; A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**
- **THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, OR ADMINISTERED BY, OR ASSOCIATED WITH, INSTAGRAM. BY ENTERING, YOU UNDERSTAND THAT YOU ARE PROVIDING YOUR INFORMATION TO SPONSOR AND NOT TO INSTAGRAM.**
- **AFFIDAVIT OF ELIGIBILITY, RELEASE OF LIABILITY & PRIZE ACCEPTANCE AGREEMENT MAY BE REQUIRED IF REQUESTED BY SPONSOR.**

**ELIGIBILITY:** To enter the PJ's-SentryWorld Only at PJ's Sweepstakes ("Sweepstakes"), you must be a legal U.S. resident who physically resides in the 50 United States (includes DC) and, at the time of entry, must be 18 years of age or older and have reached the age of majority in your state of residence. Employees of Sponsor (or Sentry Insurance a Mutual Company) that work at PJ's-SentryWorld, are NOT eligible. Sweepstakes is subject to all federal, state, and local laws and regulations. Void where prohibited or restricted by law.

**SWEEPSTAKES PERIOD:** The Sweepstakes consists of three (3) separate monthly sweepstakes. The entry periods for each of the separate sweepstakes appears in the table below. Each sweepstakes begins at 12:00 a.m. Central Time ("CT") on the listed start date and ends at 11:59 p.m. CT on the listed end date.

**HOW TO ENTER:** Follow @pjs\_sentryworld on Instagram. Once you are following @pjs\_sentryworld, and during the entry period for one of the monthly sweepstakes, post a photo of your favorite PJ's menu item with a caption that includes @pjs\_sentryworld and the following hashtags: **#OnlyAtPJs** and **#Sweepstakes**. You will receive one (1) entry into that month's sweepstakes. Entrant's Instagram profile settings must be public. Sponsor may not be able to receive entries that originate from non-public accounts, or that do not include both required hashtags, or make the required tag. Sponsor is not responsible for failing to see or receive an entry that does not follow the posting instructions set forth in these Official Rules.

Entries from one sweepstakes will not roll-over to subsequent sweepstakes. For purposes of clarity, you may enter into each of the three (3) separate monthly sweepstakes, but you will need to submit a new entry during the entry period for each monthly sweepstakes.

Entries that are lost, late, incomplete, illegible, corrupted, mechanically reproduced, falsified, mutilated, damaged, altered or otherwise irregular, misdirected entries, or entries not received for any other reason will be void and disqualified at Sponsor's sole and absolute discretion. Limit one (1) entry per person per monthly sweepstakes.

**PLEASE NOTE:** Individuals depicted in the entry photo, if any, must be the entrant and/or his/her child or legal ward. No other individuals may be depicted. Photos of menu items may be photos of menu items taken at the restaurant or may be photos of menu items obtained from PJ's website or other social media sources. Instagram posts and comments are available for public viewing, and no privacy is provided. Entry photos will also be available for public viewing on [Sponsor's website](#). Entries must contain @pjs\_sentryworld and the two required hashtags – **#OnlyAtPJs** and **#Sweepstakes** – but captions will not otherwise be judged, and the quality of an entry/caption will not affect entrant's chances of winning. Entries must be entrant's original creation and may not include copyrighted, trademarked, patented, or previously published material, except those photos made available for use by the Sponsor. Entries requiring license or usage rights from any third party are not eligible. Entries cannot defame or invade the rights or privacy of any person, living or deceased, or otherwise infringe upon any third party's personal, proprietary, or intellectual rights. Entries cannot contain illegal or unlawful material, and must not promote bigotry, racism, harm, or discrimination. Entries must be consistent with Sponsor's reputation in the marketplace and must be suitable for audiences of all ages. Except as provided above, entry constitutes entrant's certification that s/he is the owner of the entry, has received the consent of anyone depicted in the entry, and is able and authorized to submit it. By submitting entry, entrant agrees to indemnify and hold harmless Sponsor, Instagram, and their parent companies, subsidiaries, affiliates, sales representatives, agencies, retailers, wholesalers, distributors, and promotional and other vendor agencies involved in this sweepstakes from any and all claims, damages, expenses, costs (including reasonable attorney fees) and liabilities (including settlements), resulting from or relating to entrant's submission, or any information supplied or represented to Sponsor by entrant.

**PRIZES AND APPROXIMATE RETAIL VALUE ("ARV"):** One (1) Prize will be randomly awarded for each monthly sweepstakes. The Prize for each of the three (3) separate sweepstakes consists of the following: PJ's-SentryWorld Promotional Gift Card for one (1) free appetizer. (ARV: \$15.00)

Winning a Prize is contingent upon fulfilling all requirements set forth herein. *PLEASE NOTE: All taxes on Prizes are the sole responsibility of the winner.* Any and all guarantees and warranties for merchandise prizes are subject to the manufacturer's and/or service providers' terms and conditions, and winner agrees to look solely to such manufacturers and/or service providers for any warranty or guarantee claim. Gift cards may be subject to terms and conditions. Where not prohibited, affidavit of eligibility (including SSN), prize acceptance form, tax information, publicity release, and/or mutually acceptable liability releases may be required from winner. Prize is not transferable and no substitution or cash equivalent is allowed, except in Sponsor's sole discretion. Sponsor reserves the right to substitute prize of the same approximate retail value if advertised Prize becomes unavailable for any reason. If the value of the Prize exceeds \$600, the winner's social security number or taxpayer I.D. will be required in order to issue a Form 1099-MISC showing prize ARV as income to winner. Prize consists only of items specifically listed as part of the prize. All costs and expenses not specified herein relating to the Prize are the sole responsibility of the winner. Value of appetizers may fluctuate and will depend on the appetizer chosen; any difference in value between the chosen appetizer and other appetizers will not be awarded, and no such claims will be honored.

**RANDOM DRAW & ODDS OF WINNING:** Within three (3) days of the end date of each monthly sweepstakes, a random draw will be conducted from all entries received during the respective monthly entry period. Odds of winning depend on the number of eligible entries received during the respective monthly entry period. Selected entrant will be notified by a post and/or direct message on Instagram within three (3) days of winner selection.

**WINNER CONFIRMATION:** To be confirmed a winner, the selected entrant must: (1) respond as instructed within three (3) days to the post or direct message; and (2) if requested by Sponsor, winner may be required to execute and return within a specified time an Affidavit of Eligibility, Publicity Release, and Release of Liability (collectively, "Winner's Documents"), that includes, without limitation, acceptance of the Prize, tax information, assignment of rights, and/or mutually acceptable liability releases, as requested by Sponsor, except where prohibited by law. If the selected entrant cannot be

confirmed a winner for any reason, or if the Winner's Documents are not fully completed within the specified time or are returned as undeliverable, s/he may be disqualified and the Prize will be forfeited and an alternate winner will be chosen. Upon responding to Sponsor's notification, Sponsor will provide winner with instructions on prize delivery/gift-card pick-up options.

**PUBLICITY RELEASE:** Except where prohibited, acceptance of the Prize constitutes winner's consent that his or her name, likeness, voice and/or biographical data may be used for advertising and promotional purposes without limitation and without additional notice, compensation, or consent.
